#### **DISCOUNTS AND SAVINGS:**

- Military Discount (1 per family): \$5.00 off registration with proof of military ID. Customers mention the need for the discount at registration.

- Family/Multiple Student Discount: You will receive a discount / savings for having two or more students actively enrolled in the company. 2 students enrolled = \$5.00 OFF monthly tuition, 3 or more students enrolled = \$10.00 OFF.
- Referral Program: Receive a \$20 J&J Credit for new students that sign up as monthly members. Credit is applicable toward tuition, merchandise, snack shack purchases, and show fees. This does not apply to costumes, team apparel, or special events. (see details)

## **DROP / UN-ENROLL PROCESS**

If you decide to unenroll from the company or withdraw from classes in your current schedule, please submit a formal email to [info@jandjhiphopdance.com](mailto:info@jandjhiphopdance.com). A request to unenroll must be submitted before the start of the upcoming billing cycle. Please note that any classes dropped after the 1st of the month will still incur charges for that month. ## CLOSURES & BREAKS 2026

Please NOTE: Tuition remains the same even with shorter or longer months. 2026 Classes resume on Jan 5th, 2026. Tuition / membership rates are based on our full year (approx. 44 weeks) averaged out per month, including breaks. The amount of any single month installment is not based on the number of classes for that month; it represents 1/12th of the annual session's tuition. Our 44-week sessions include adjustments for holidays and breaks throughout the year. If there is a break, such as Spring Break, Fall Break, or a holiday, students may make up their missed class within 30 days (refer to the makeup class rules).

3 Snow Days a year are considered (See Inclement Weather section below). In addition, 2026 holidays that fall on days we have classes, a make-up class may be offered. See or call the office for details.

Monthly tuition is required for J & J Hip Hop Dance Company members regardless of class attendance; it does not depend on the number of classes attended each month. Class attendance is the student's / parent's responsibility as classes are available each month.

## MAKE UP CLASSES

A total of six make-up classes may be used in a given year (2026). To make up for missed classes, please schedule this with the Dance Director or Office Manager. A 24-hour notice for missing a class still applies in order to be approved for any "Make Up" classes. You must use your "Make Up" class option within 30 days of your missed class or your "Make Up" class.

*(Make up classes are not the same class the student attends. This means that students can find a class on the schedule that is within age and level range to try as an added day of dance in the month. These classes must be approved, and instructors will need to be notified of the student that is taking the class as a "Make Up." Make up classes are NOT private lessons with instructors. Those can be set up separately for an additional cost. See office for more details.)*

J & J Hip Hop Dance Company will NOT allow a "Make Up Class" under the following circumstances: 1. If notice is not given at least 24 hours in advance for an absence. 2. If you missed class without attending, calling, or giving proper notice. 3. J & J Hip Hop Dance

Company owners reserve the right to deny "Make Up" classes on circumstances falling out of between the above situations. \*NO EXCEPTIONS TO "MAKE UP" CLASSES CAN BE MADE OUTSIDE THESE GUIDELINES AND POLICY.

**\*INCLEMENT WEATHER**

**3 Snow Days a year are considered.** On occasion classes may need to be canceled due to inclement weather conditions or for other unforeseen circumstances. In these instances, please call our studio 719-418-5974 to hear a message about closures or delays. You may also look for updates via text, email, socials, or KKT News Television Station for updates and important announcements.

J & J Hip Hop Dance will do its best to notify you ahead of time about cancellation or closing. Be sure to provide a current email or text number on your parent portal for these specific notices.

The Monthly Tuition will not be adjusted or prorated for any weeks in which the studio may be closed or for longer or shorter months. We have already considered closed classes for inclement weather, holidays, throughout the year breaks, and our overall operating costs when deciding the 2026 Monthly Tuition Rate.

# GENERAL COMPANY RULES, PROCEDURES, CLASS ETIQUETTE

## GENERAL COMPANY RULES, PROCEDURES, CLASS ETIQUETTE

- Dancers must attend classes, festivals, performances, recitals, competitions, as arranged and scheduled ahead of time.
- Dancers will need to maintain a positive attitude towards the class instructors and fellow students at all times. We have a ZERO tolerance for insubordinate behavior from students, parents, guests, and reserve the right to unenroll a student at any time without refund.
- Please be ON TIME for your classes as it is important to warm up properly to avoid injury.
- No student(s) will be allowed into the class 20 minutes after the class has commenced, unless previous arrangements have been discussed and warm up is still done before joining the group.
- Students should always come to class in dancewear or in attire as appropriate for dance & performing arts classes. Hip Hop, Breaking, & Lyrical Hip Hop students should wear gym style clothes (jogging suit or loose sweatpants and a comfortable shirt).
- J & J is a conservative and family friendly atmosphere; dancewear should cover the majority of the dancer's person (see below specific class attire). **NO MID-DRIFT TOPS. NO PULLING UP SHIRTS IN FRONT OR IN BACK. NO SPAGHETTI STRAPS. TANK TOP STRAPS ARE TO BE AT LEAST 2". NO LOW CLEAVAGE. SHORTS MUST BE MID THIGH OR LONGER. NO INAPPROPRIATE VERBIAGE / LOGOS OR LANGUAGE ON CLOTHING OR ACCESSORIES.** (*Anyone breaking the dress code will be asked to change / fix their attire immediately. If a student is not complying, we have the right to ask students to leave the studio.*)
- A personal labeled water bottle is needed in class for easy water access.
- Students should always come to class groomed and clean (i.e., clean clothing, deodorant applied prior to practice, etc.). Any hygiene that is without proper care will be noted to the student and need proper correction by the following class. Please use proper feet hygiene (powders, deodorants, sprays etc.).
- Students will be required to commit to the warmups and exercises as instructed.
- Soft and durable knee pads are encouraged for floor work and some breaking elements to protect the dancer's knees from injury.
- **HIP HOP:** Proper tennis shoes with decent rubber soles are required, NO flat-soled shoes (needs to have cushion and arch) and must be comfortable to move in. The sole of the shoe should be solid and have traction, so the student does not slide too much on the floor. **NO OPEN-TOED SHOES, NO BOOTS, NO HEELS.**
- **BALLET:** Ballet students are required to wear specified uniforms for class. These include tights and a leotard (specific to level and class), lightweight ballet skirt, and neutral ballet shoes are required for classes. Hair must be up and away from the face.
- **TAP:** Classes will require tap shoes; pants should not drag on the floor or cover taps fully.
- **CONTEMPORARY & JAZZ:** Contemporary will require a half turn lyrical shoe (ask for type of shoe). Jazz requires a jazz shoe. Please refrain from wearing baggy pants. Leggings are preferred to see and correct dance form.

- Other classes (Teams, Competition Team, Company, Musical Theater, Krump, & more) will be instructed if there are any classroom attire requirements. \*Additional Expectation Forms will be required for teams.
- Viewing classes (Parents, Guests, Siblings, Friends, etc.). J & J Hip Hop Dance Company may allow the dance student's parents, guardians, and friends to observe classes from parent viewing areas outside the studio. No one other than the Instructors or staff are allowed inside the dance training areas. This is a safety concern, and your understanding is appreciated.
- We have comfortable convenient waiting areas with complimentary WiFi and TV screens for entertainment. We often offer complimentary coffee, tea, hot cocoa to our parents and guests that like to hang out inside.
- Our facility offers a Snack Shack where you can purchase J & J merchandise, snacks, small treats, drinks, & candy while you are waiting. Students can also recharge between classes.
- We encourage our dance parents to form friendships and connections with other dance parents.
- We have a zero-tolerance policy for irate parents, guests, and / or irate student behavior. Any display of this type of behavior or incidents will result in immediate unenrollment without refund. We work hard to ensure a safe and positive environment at our studio and appreciate the overall support to achieve this atmosphere.
- If a guest of the dance student is causing a disruption to the class, the guest will be asked to leave the premises. If the guest does not cooperate, the responsible dance student and the guest will be asked to leave the premises. A meeting or phone conference will need to be arranged with the parent of the student and conducted, along with a resolution to the problem before the responsible dance student or guest can return to class.

## **INJURY & SAFETY DISCLAIMER**

All dance classes can involve the risk of personal injury! J & J Hip Hop Dance, LLC takes all reasonable care in the conduct of its classes; it accepts no responsibility for injury or loss caused during classes or while participants are at or near the dance studio. You are responsible for ensuring that you are physically and medically fit for the class and during the class you must take care of your own personal safety at all times. \*Please reference the student "Waiver of Liability & Hold Harmless Agreement" in your Student Enrollment Form for additional details.

- Lost or Stolen Property: J & J Hip Hop Dance Company does not have lockers available on location. Please secure your valuables at all times or leave them at home if a loss risk is possible. If you take a personal gym bag into the dance studio with you, leave it in a location where you can keep it in your view. Do not leave bags or clothes in the dance studio or restrooms at the end of class. Please remember to take everything with you after class. We cannot take responsibility for anything left behind. For any property left behind, check with the instructor to see if anything was found or you may check the lost and found area.

## REFUND POLICY

**No refunds available.** This is a strict and firm policy. Clients understand that all sales are final. We do not operate on seasonal contracts as most dance companies require. Therefore, each monthly membership payment is to secure your membership each month as your agreement to attend. If you choose to pay ahead for any events, classes, or sessions, you are securing your spot and will assume your attendance. If any insubordinate incidents occur in the meantime (see "General Company Rules), you will assume responsibility for the loss. No transfer of credits to any fellow classmates are allotted.

# Auto Pay Policy

### **Auto Pay Policy**

Auto Pay is required for all accounts. A valid credit card must be kept on file, and tuition will be automatically charged on the 1st of each month. Billing is posted by the 25th, and payment is due by the 1st. You may pay early through your portal; otherwise, the system will process payment automatically.

A strict \$20 late fee will be applied to any account not paid by the 2nd 11:59, and students with outstanding balances will not be permitted to attend classes until payment is received. If you anticipate payment issues, please notify us in advance to discuss possible solutions. Otherwise, late fees will apply, and class attendance will be suspended until the account is current.

# Registration and Tuition Policies

## **Registration and Tuition Policies**

### **Registration Fees**

For the 2026 dance year, the Annual Enrollment / Registration Fee is structured as follows:

- \$55.00 for the first student
- \$45.00 for the second student
- \$35.00 for the third student

Note: If a student is un-enrolled for more than 30 days at any time in 2026, the enrollment fee will be required again upon re-enrollment.

### **Loyalty Program**

Students who have been enrolled consecutively for 3 or more years as of January 2026 are exempt from paying the annual registration fee.

### **Tuition and Membership**

#### **Billing and Payment**

- Tuition is billed on the 25th of the current month and is due by the 1st of the upcoming month.
- A valid card must be on file for enrollment or re-registration, and all accounts will be billed automatically on the 1st of each month.

#### **Payment Options**

- If you wish to pay using cash, check, or a separate card (different from the one on file), payment must be completed before 1st of the month to stop the AUTOPAY generated on the 1st.
- If payment is not made or communicated to the office by this time, the card on file will be charged at 11:59am on the 2nd.

#### **Late Payments and Fees**

- If the card on file fails to process due to insufficient funds, expiration, or any other reason, a late fee will be applied by the 2nd of the month.

- Students with unpaid accounts will not be permitted to participate in classes until the issue is resolved with the parent or guardian.
- Failure to pay on the due date will incur a \$20.00 late charge on the 3rd day after the payment is late.
- If a check is returned due to insufficient funds, the class fee plus a \$25.00 Returned Item Fee must be paid within 7 days. Future payments may require a different method if checks are declined.

#### Termination and Consecutive Payments

- Enrollment may be terminated at the discretion of the Business Manager for accounts that remain excessively delinquent.
- Tuition payments are due on the 1st of each month and act as a monthly membership fee, not based on the number of classes attended.
- If a student stops attending classes without paying tuition consecutively, they must re-enroll and pay the enrollment fee again for 2026.
- Continuous payment is required to retain a student's spot in class, regardless of attendance.
